RE: Including the Potomac Yard arena in the budget conference report

Dear Chair Lucas and Chairman Torian,

On behalf of the Coalition to Stop the Arena at Potomac Yard ("Coalition"), we urge you and your fellow conferees to oppose the inclusion of any language in the state's budget bill that would result in a publicly funded arena being built at Potomac Yard. The Coalition represents thousands of Alexandria and Arlington residents, millions of potentially impacted Virginians, and advocacy organizations from across the ideological spectrum who all oppose Governor Youngkin's proposed arena deal in Alexandria. We applaud Chair Lucas, in particular, for her steadfast opposition to SB 718. We also acknowledge and appreciate the many important and as yet unanswered questions that both of you and your colleagues in the General Assembly have raised about the arena deal since it was announced only eleven weeks ago. Over the coming days, you and your fellow budget conferees will make key decisions about whether to include in the conference report language that will saddle generations of Virginians with the costs of this ill-conceived plan. If the arena plan moves forward, funds that would otherwise support projects that could benefit all residents of the Commonwealth will instead be diverted to debt service and maintenance on an arena whose biggest beneficiary will be Monumental Sports & Entertainment and its billionaire owner. Despite what arena proponents repeatedly claim, decades of economic analyses show that arguments that the deal will "pay for itself" are not supported by independently produced and peer-reviewed evidence.¹ The process by which this proposal has been presented to the public has also been unacceptably opaque. Key documents (often heavily redacted) that would support or discredit claims by stadium backers have only emerged in recent weeks, and often only after Freedom of Information Act requests by media.¹¹ When such evidence has finally emerged and been analyzed by independent sources, the economic impact and cost claims of stadium proponents have been found to be highly suspect.¹⁰¹

Finally, the majority of residents of Alexandria simply do not support this proposal, based on recent polls^{iv v} and petitions.^{vi} At a February 24 Alexandria City Council hearing, thirteen speakers spoke in opposition to the arena project and only one person spoke out in favor of it. The public record is filled with as-yet unaddressed concerns about the impacts of the proposed arena on transportation,^{vii} the environment,^{viii} ix the Commonwealth's financial well-being,^x affordable housing,^{xi} and labor.^{xii} Public comments at the House Appropriations Committee hearing on February 9^{xiii} and community meetings^{xiv} about the deal have been overwhelmingly against the proposal. Even leaders of the Northern Virginia Republican Party have come out in opposition to the Governor's plan.^{xv}

The Potomac Yard arena deal is simply bad policy, unsupported by independent economic evidence, and opposed by the public and leading members of Governor Youngkin's own party. It is time to finally close the book on this proposal and keep it out of the final budget conference report.
